HOW TO PREPARE

1. Bring everyone in the choir - they will have great fun. You do not, however have to have a full choir to participate.
2. Purchase the repertoire listed above and prepare it in advance. We don't expect it to be perfect, this is a day to work together and learn.
3. Bring your bells, chimes, foam, covers, mallets - whatever you use in your program. There are some tables available at the site, be sure to mark your table needs on the registration form.
4. Wear comfy clothes and shoes.
5. Be prepared to try new things. Dr. Behnke will be teaching a variety of simple, easy handbell applications for use in worship. You will receive materials to take home and use immediately.
6. There is no concert, but rather a Final Gathering which will be a simulated service, utilizing the massed music and all the special applications we have worked on.
